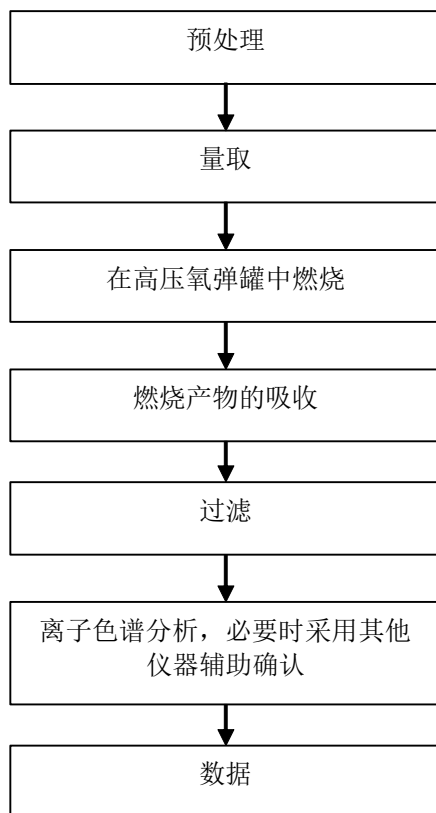

## 卤素和硫(氧弹法) 检测流程图



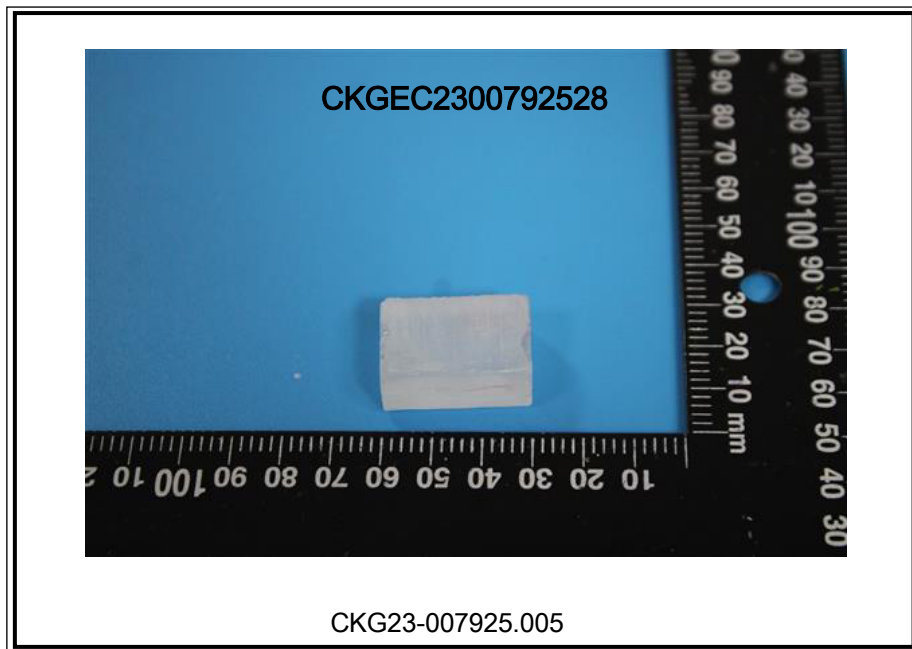
